## NOTIFICATION

In exercise of the powers conferred by the proviso to Article 309 of the Constitution, the Governor of Rajasthan hereby makes the following rules further to amend the Rajasthan Civil Services (Medical Attendance) Rules, 2013, namely:-

1. Short title and commencement.- (l) These rules may be called the Rajasthan Civil Services (Medical Attendance) (Second Amendment) Rules, 2024.

(2) They shall come into force with immediate effect.

2. Amendment of rule 3.- The existing clause (9) of rule 3 of the Rajasthan Civil Services (Medical Attendance) Rules, 2013 along with its explanation shall be substituted by the following, namely:-

"(9) "Family" means Government Servant's -

- (i) spouse,
- (ii) wholly dependent son including legally adopted son till he gets married or starts earning income as prescribed in Appendix-XIV or attains the age of 25 years, whichever is earlier,
- (iii) wholly dependent daughter including legally adopted daughter/legally divorced/widowed daughter till she gets married or starts earning income as prescribed in Appendix-XIV whichever is earlier,
  - Explanation: For the purpose of sub-clause (ii) and (iii) son /daughter including legally adopted son/daughter suffering from any permanent disability of any kind (physical or mental) shall be treated as dependent irrespective of his/her age or marital status.
- (iv) parents excluding step parents, or legally adoptive parents or parents-in-law.

Explanation: For the purpose of sub-clause (iv),-

- (a) parents excluding step parents, legally adoptive parents or parents-in-law shall be deemed to be wholly dependent, if their recurring total income from all sources does not exceed the limit as prescribed in Appendix -XIV;
- (b) parents or legally adoptive parents, who are dependent on the Government Servant are not required to reside with Government Servant;
- (c) adoptive parents can be included in the definition of family under these rules only if his/her parents are not included as a member of the family;
- (d) parents-in-law who are residing normally with the Government Servant can be included as family member under these rules only if his/her parents are not included as a member of the family. An option regarding choice to include either his/her parents or his/her parents-in-law shall be

declared by the Government Servant on the RGHS portal. Declaration already given or option once exercised under the RGHS can be changed only once during service period; and

- (e) if the adoptive father has legally more than one wife, only senior most wife shall be treated as adoptive mother and other being step mother shall not be included in the definition of family.
- Note: 1. A declaration regarding income of parents and children shall be furnished by the Government Servant on the RGHS portal.
  - 2. Any change in family member shall be declared on the RGHS portal."
