ORDER

Sub: Rajasthan Civil Services (Medical Attendance) Rules, 2013 - Maximum Chargeable rates of RGHS for treatment in Health Care Network Provider (HCNP).

Ref: Finance Department order of even number dated 26-07-2023.

In exercise of the power vested under Rule 20 of the Rajasthan Civil Services (Medical Attendance) Rules, 2013, and after considering decision of HBEC constituted under rule 4 of these rules, the State Government has decided that :

1. "Note" below the table of point No. 2 of even number order dated 26-7-2023 is hereby deleted and substituted by the following:

"**Note :** 1. No prior approval is needed for higher cost medicines. Hospital shall produce bills at the time of discharge of patient, which shall be duly checked at the level of RGHS.

2. The hospital shall be bound to submit their claims of medicines on the same rates as other pharma stores supply medicines to RGHS Card holders i.e. 12% deduction for ethical medicines and 40% deduction for generic medicines."

2. Regarding NICU package code, the following items shall be applicable for Medical Management. The length of Stay shall be restricted for 5 days:

Note at point No. 1 shall also be applicable in case of NICU package code.

3. For the length of Stay in the case of cancer surgery, the duration of treatment shall be considered at par with CGHS order dated 7-9-2015 point No. 2.2, in which it is mentioned that in various surgical procedure for treatment of cancer the gradation as category I - @ 1 to 2 days, category-II @ 3 to 5 days (7 to 10 days only in case of operations involving abdominal / thoracic cavity and category - III, IV, V and VI - @ 12 to 14 days.

This order shall come into force with immediate effect.
