**CIRCULAR**

**Subject: A. Promotion of prescription of generic drugs by medical practitioners-Reg.  
B. Discount on medicines & disposables.**


Reference is invited to CGHS circular No. H-11013 / 7/ 2012-CGHS (P) dated 8<sup>th</sup> February 2013 and no. S-11011 /16/2012 -CGHS dated 3<sup>rd</sup> May 2013 emphasizing the need of prescribing generic drugs. In this regard it is stated that as per CGHS circular no. S-11011 / 16/ 2012-CGHS (P) dated 8<sup>th</sup> April 2015, it is reiterated that all Specialists / Doctors working in Private RGHS empaneled hospitals are hereby directed to ensure that Generic drugs are prescribed to the maximum extent possible with a view to make medical treatment cost effective and affordable.

In light of implementation of CGHS packages for RGHS empanelled hospitals, it is stated that RGHS empanelled hospitals shall follow the discount of 10% on all medicines under medical / surgical management including discharge medicines w.e.f. issuance of this circular.


All RGHS empanelled hospitals will make sure to implement the above with immediate effect.

**CIRCULAR**

**Subject: Claim submission with respect to Query raised by RGHS**

All private RGHS empaneled hospitals are directed to submit the Claims as per the online format. It has been observed that hospitals do not respond to the query even when asked more than once, for the same subject/ document submission. In this regard it is stated that for all queries which are raised twice for the same subject and are not responded by the hospitals, then the respective Claim will be rejected and further such rejected claims will not be reopened by the committee.

In Claim submission process there will be one time query only for the following:

- Long stay approvals - failing which there will be deduction in claim amount for the number of days lacking the approval period.
- Purchase invoice for investigations/ implant above Rs.20,000/- failing which the amount will be deducted from claim submission amount.

All hospitals are hereby notified as above and are requested to attend to the queries timely with appropriate response to avoid Claim rejections.
