
**Subs: Provision of Oxygen concentrator, in respect of RGHS beneficiaries for domiciliary use
Grant of permission / ex-post facto approval and reimbursement of the cost of the same .**

- I. In is stated that the office of rajasthan government health scheme(rghs) has been receiving request from RGHS beneficiaries for permission to purchase oxygen concentrator as prescribed by the specilist doctor and the claim reimbursement of the cost of above and machines for domiciliary use.
- II. with reference of CGHS Office memorendum no. s. 11011/4/2014-cghs dated march05, 2014 and subsequent order june03,2019the following guidelines have been frame for grant such machines to the RGHS cardholders. These machines are allowed to be purchased once in life-time with the condition that the responsibility and maintenance of the said machine would lie with the beneficiary as per the Office memorandum no. 24-26/96/R&H/RGHS(P) dated june26, 2001.
 - a. The undersigned is directed to state that the Ministry of Health & Family Welfare has been receiving requests from RGHS beneficiaries for permission to purchase Oxygen Concentrator. As prescribed the specialist doctor and claim reimbursement of the cost of above said machines for the second time and also for reimbursement of expenditure incurred on maintenance of these machines which were
 - b. The beneficiary has also to submit an undertaking to the effect that end claimed reimbursement of the cost of the machine in the last five years (copy format for the affidavit and the undertaking is enclosed).
 - c. The machine is to be deposited back with the CMO In-charge of the RGHS Wellness Certar concerned after the utility of the same is over and the machine will not be re-ssued to another patient by RGHS. CMOs In-Charge in Rajasthan will deposit the used machines to RGHS Medical Stores. CMOs In-charge in otherRCGHS cities will deposit these used machines in the Office of Additional Director of the RGHS city and obtain acknowledgement. The concerned offices will maintain complete records of such machines
- III. Individual requests for permission/ex-post facto approval shall be considered by the screening committee consisting of:-

- IV. The maximum ceiling limit for reimbursement will be as following:
➤ Oxygen Concentrator- Rs. 45,000/ + GST (As per cghs office memorandum no. 14025/55/2019-dated 27may 2021)
- V. The above ceiling limits include cost of maintenance with spare parts for a period. Bi-level Ventilatory system of five years No request for reimbursement of cost of maintenance/parts will be entertained.
- VI. Request for replacement of machine after completion of five years will need to be advised and processed in the same manner as for the first machine. viii) Request for permission/ex-post facto approval of these machines, complete in all respect as mentioned above may be sent to:-


