Process Flow:

The following process flow defines sequential step by step process for RGHS registration module for pensioners (Retired Judicial Officers). Each step has been also detailed out with sample screens, business validations and integrations with other applications. Below is the sequential flow:

- ❖ **Step 1:** Click on rghs.rajasthan.gov.in.
- ❖ **Step 2:** Home Page will appear
- ❖ **Step 3:** Click on Registration Tab
- ❖ **Step 4:** Redirected to SSO log in page (To Proceed Further Please Click on sso.rajasthan.gov.in)
- ❖ **Step 5:** Logging in Through SSO ID: Pensioner will log in through SSO.rajasthan.gov.in
- ❖ **Step 6:** Link for RGHS (Icon): Click on RGHS Icon. Click on Register as retired judicial officer (pensioner and family pensioner) tab for further registration
- ❖ **Step 7:** Land on RGHS application showing categories of registration as:
 - Register as Pensioner (AIS & Pensioners Prior to 01-01-2004)
 - Register as Judicial Officer (Retired)
- ❖ **Step 8:** User will select **Judicial Officer (Retired)**

Process Flow: (Continued)

❖ Step 9: Registration on RGHS through Jan Aadhar:

- ☐ **Display of Jan Aadhar Family:** User provides Jan Aadhar or enrollment number to display Jan Aadhar family associated to Jan Aadhar number.
 - If Jan Aadhar number is “Not Available” RGHS portal redirects user to Jan Aadhar portal for creation of Jan Aadhar ID.
 - If Jan Aadhar number is “Available” – RGHS portal displays the Jan Aadhar Family along with the column for selection of pensioner.

- ☐ **Identification/Selection of Pensioner:** Limited to select only one government employee which will be having the right to define relationship.

- ☐ **Verification (verification from (verification from of PPO Number, DoJ and DoR)**
 - a) If verified “Yes” then it will lead to next of step of registration
 - b) If verified “No” then a message will appear PPO No. or DoJ or DoR are incorrect, unable to Register

- ☐ **Defining Relationship with respect to Pensioner:**
 - a) User will define his own family relationships to be covered under RGHS and can select the category.
 - b) In case if spouse is Government Employee -category and Employee ID will be taken
 - c) In case if spouse is Pensioner -category, PPO No., DoJ and DoR will be taken

- ☐ **Validations of relationships:** Basis on the information provided by user, system will be able to identify dependents under family as per the following guidelines. Family definition is Annexed below

- ☐ **Declaration/Acceptance/Disclaimer:**
 - a) By registering, system will allow the member to register/validate.
 - b) Without continuing the acceptance, system will not allow the member to register/validate.

- ☐ **“Successfully Registered” : Registration process will be completed by clicking on submit button”.**

Family Definition (As per guidelines)

❖ RGHS 4b Retired Judicial Officers

“Family” means Government servant’s spouse, wholly dependent children, legally adopted children (including legally divorced / widowed daughter) and parents (excluding step-parents) irrespective of where they reside. (i) Parents shall be deemed to be wholly dependent if their recurring total annual income **from all sources does not exceed the limit as prescribed in Appendix- XIV.** (ii) A declaration regarding income of parents and children shall be furnished by the Government servant. (iii) Any change in family shall be declared by the Government servant. (iv) Dependent children shall mean and include:

(a)	Son	Till gets married or starts earning income as prescribed in Appendix-XIV or attains the age of 25 years, whichever is earlier.
(b)	Daughter	Till gets married or starts earning income as prescribed in Appendix-XIV whichever is earlier.

Note: Son/daughter suffering from any permanent disability of any kind (physical or mental) shall be treated as dependent irrespective of his/her age or marital status.

Legally adoptive parents who are dependent on the Government servant, irrespective of where they reside, shall be member of family as ‘parents’ as defined in sub-rule (9) of Rule 3 of Rajasthan Civil Services (Medical Attendance) Rules, 2013 provided that in any circumstances the real parents shall not be member of the family under the aforesaid rules. In case if adoptive father has legally more than one wife, only senior most will be adoptive mother and others being ‘step-mothers’ will not include in the definition of family as ‘parents’ under the aforesaid rules.

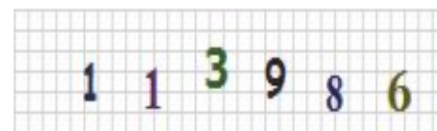

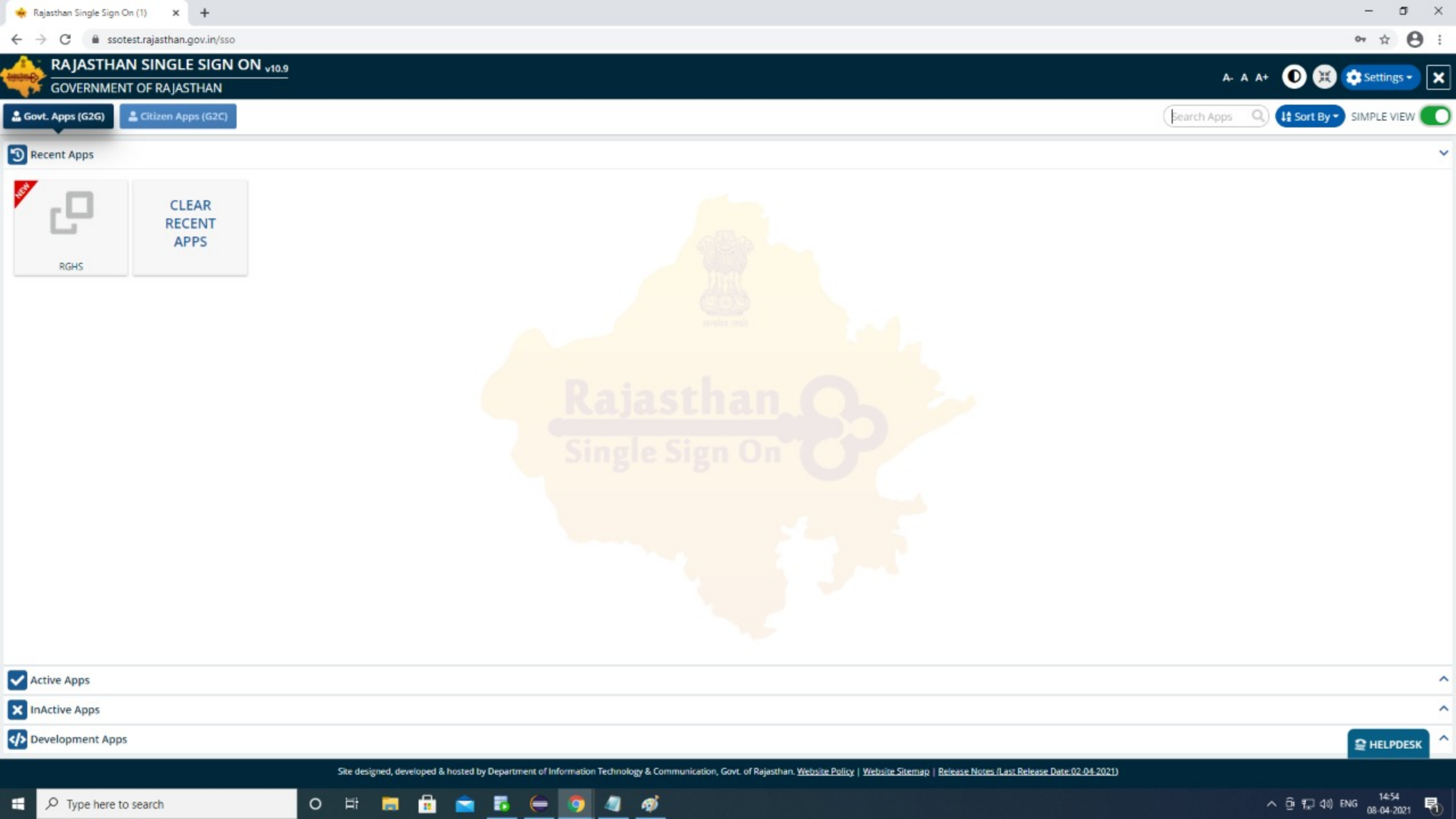
